- 1. <u>Call to Order</u> The meeting was called to order at 5:25 pm.
- 2. Roll Call All present.
  - Comments from the Public None.
- 4. Consent Calendar
  - A. Adoption of a Resolution of the Board of Commissioners of the Housing Authority of the City of Berkeley Making Findings Authorizing Continued Remote Teleconference Meetings of the Board of Commissioners Pursuant to the Ralph M. Brown Act, as Amended by Assembly Bill 361 Moved by Vice Chair Levine, seconded by Commissioner Rossi, the Resolution passed (all in favor).
- 5. <u>Closed Session</u>: Public Employment (Ca. Government Code § 54957) Title: Executive Director Closed session ended at 7:08 pm with nothing to report out.
- 6. Approval of Minutes: Moved by Commissioner Rossi, seconded by Vice Chair Levine, the minutes of the August 11, 2022 Special Board Meeting were approved (all in favor except Commissioner Kashani left meeting at 7 pm).
- 7. New Business
  - A. Nomination and Election of Officers: 2022-2023 Chair and Vice Chair Moved by Commissioner Rossi, seconded by Commissioner Moody, Chair Schildt was nominated for position of Chair (all in favor, except Commissioner Kashani absent); Moved by Commissioner Rossi, seconded by Chair Schildt, Vice Chair Levine was nominated for position of Vice Chair (all in favor, except Commissioner Kashani absent).
  - B. Executive Director's Monthly Report Rachel reported: (a) EHVs: 46 EHVs processed by staff with 24 leased up in Berkeley or other jurisdictions via portability; 10 removed due to passing away or absorption by another PHA; County still gathering applications for remaining 7 applicants. HUD has offered 32 hours or technical assistance on the EHV program, staff held a kick off meeting with the technical assistance providers, Center for Supportive Housing (CSH), as well as a follow up meeting with the EHV collaborative partners. (b) Mainstream: 73 of the 91 Mainstream

Vouchers are leased up; 16 are searching for units; staff processing 2 remaining referral applicants; HUD awarded \$45,500 in extraordinary funding to be used for retention, recruitment, and support of landlords in the Mainstream program. Staff is meeting to identify implementation and noticing landlords of these funds. (c) Celinda provided data on the July HCV Waitlist opening, including: over 7,000 applications received on the first day; 12,131 single person household applicants; 9,974 family applicants; 2,553 elderly heads of household; 605 veterans; 5,383 disabled status; 34 Spanish applications and 168 Mandarin applications received, with 21,902 in English. 22,105 applications received over the 8-day period, with 2,000 randomly selected applicants making it to the new HCV waitlist.

- C. Adoption of New Classifications: Policy Manager and Accounting Specialist; Re-establishing Housing Occupancy Manager Position No motion made.
- D. Helios Corner: Approval of 5 Year Extension of Project-based Master HAP Contract Moved by Commissioner Rossi and seconded by Commissioner Moody, this item was moved after the Consent Calendar. No motion made on this item; Commissioner Kashani and Vice Chair Levine volunteered for a Subcommittee on Helios Corner, to determine further information to request of SAHA.
